By sharing our **COVID-19 Dashboard**, Niles Community Schools is attempting to accurately portray the number of staff and student positive cases that are present in our schools and the number of staff and students who are quarantined.

Berrien County Health Department (BCHD) provides us with this information and every Friday we take a snapshot of our counts and post them on our dashboard.
